A meeting of the freshly elected PTA was convened in the Principal's office on 21 September, 2019.

Ms. Nandini Pathania congratulated the elected members and said that their support for the smooth functioning of the college was very important. The following matters were discussed and finalized:

- 1. It was decided to hold the PTA meetings twice in a session with at least a prior ten days notice to the PTA members.
- 2. The PTA decided to appoint a Sports Coach, from the PTA fund on an hourly basis with the upper limit being Rs.17000/- per month.

3. Ms. Nandini apprised the PTA members of the delay in the renewal of permanent posts by the Govt. and requested the PTA to look into this matter in their individual capacity and help expedite the case.

With this the meeting came to an end.

March 3, 2020

Eight members of the PTA held a meeting at 2.30pm in the Principal's office on March 3, 2020. The meeting started with the reading of the previous minutes by Ms. Anuja Sharma, Secretary PTA, they were passed with a proposal by Mr. L.D. Pal and seconded by Dr. Sapna Sharma. Matters arising out of the minutes were discussed regarding the appointment of a Coach for sports.

The following decisions were taken:

- 1. Mr. Navlesh, President of the PTA said that the only concern of the PTA members was the welfare of the students. A coach for sports activities is a must so that students can play whenever they are free instead of sitting with their mobiles.
- 2. Mr. Pal suggested that a multipurpose worker for the Gym and the common room can also be kept for the students benefit from the PTA funds. The payment details and timings can be chalked out by the Management.
- 3. The parent also emphasized that a Counselor is a must for the students in the present times and it was very important to have a counselor for at least 2 days a week for two hours a day to help the students with their problems.
- 4. Mrs. Shalini Thakur suggested that the college should encourage Career Counseling and Personality Development workshops.
- 5. The members also suggested that the parents of boarders can participate in these meetings by sending their suggestions to the President who can put them forward.
- 6. The PTA decided to institute a prize for general progress in Sports, Cultural activities and Academics. This award will entail a trophy and a certificate.
- 7. The PTA also decided to sponsor the Inter-College Cultural Festival Serendipity, for greater exposure of the students in terms of healthy competition and learning.
- 8. The PTA members decided to discuss further among themselves the issue of payment from the PTA fund to D.El.ed. For UG classes, requirement for a guest lecturer can be taken from the PTA fund. The lecture amount would be 250/- per lecture.

With this the meeting ended over a cup of tea.

9. Through an email sent by the PTA President Mr. Navlesh on 5 March, 2020, it was informed that the PTA members had decided that PTA funds may be used only for UG guest lecturers as when required, but the funds cannot be used for D.El.ed as the D.El.ed students do not contribute towards the PTA funds.
