## **About the Journal**

Scholars are invited to submit articles for publication to 'Journal of Research: The Bede Athenaeum', a registered journal. This multidisciplinary research journal will publish theoretical research-based contributions from National as well as International researchers in the fields of languages, arts, social sciences applied sciences and education. It will provide a forum for scholars/researchers to share experiences and ideas and even debate current issues and controversies. Bede Athenaeum welcomes conceptual and empirical articles and encourages cross disciplinary perspectives and a broad range of research approaches and methodologies.

## **Peer Review Policy**

All articles published in The Bede Athenaeum are peer reviewed through the procedure outlined below:

- i. Initial manuscript evaluation - The Editor first evaluates all the manuscripts received.
- ii. Rejection of a manuscript for lack of originality, serious flaws in approach, poor language and expression can take place at this stage. Authors whose manuscripts are rejected, will be informed within two weeks of receipt of the submitted manuscripts.
- iii. Each paper that meets the Editor's approval is now further passed on for review to two anonymous referees from within academia.
- iv. The Bede Athenaeum employs the double-blind review method in which the reviewer remains anonymous to the author throughout the process. The title page of a submitted manuscript containing the author's details, therefore must be submitted as a separate document.

## **Instructions to Authors**

- i. A declaration is to be made by the author(s) that the paper is **original**, has not been published /submitted for publication elsewhere. Authors are requested not to submit manuscripts that are under consideration for publication elsewhere.
- ii. The paper should be typed in MS word, Times New Roman in 12 pt. The length of the manuscript **should not exceed 3,500 words**. Use a single column layout with both left and right margins justified. Author(s) should submit a hard copy of the manuscript as well as by email. An electronic copy of the paper should be sent to the editor in chief or the managing editor

- iii. The cover page of the manuscript should contain the 'Title of the paper', name(s) of the author(s), designation, affiliation(s) email, phone with STD code and postal address.
- iv. The second page of the manuscript should contain only the title of the paper for the purpose of anonymity in the review process. The name(s) of the Author (s) /Affiliation should **not** be mentioned on this page at all.
- v. The third page of the manuscript should contain the title of the paper as well as a brief running title of not more than 4 key words. This page should also contain an **abstract** of the paper in not more than 250 words.
- vi. Tables must be typed in double space on separate pages. Tables and copies of illustrations should be appended to text, numbered and their position in the text clearly marked, as Table-1, or Figure-1 and so on.
- vii. The editors hope to provide authors with a decision on whether a manuscript will be accepted within ten weeks of receipt of the manuscript.
- viii. Bede Athenaem reserves the right to publish or reject any contribution submitted for publication without assigning any reason.
- ix. All references should appear at the end of the manuscript in alphabetical order and contain all bibliographical information. The reference list and citations of references in the text should follow the *Publication Manual of the American Psychological Association*, Fifth Edition (July 2001) (mainly for the manuscripts submitted in Social Sciences).
