Awareness of GST Issues: To delve into various issues related to GST, thus equipping students with a comprehensive awareness of the challenges and nuances associated with this tax system.

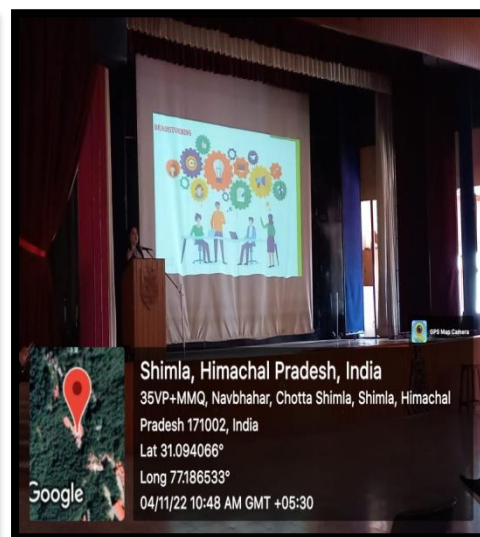

INDUSTRIAL VISIT TO THE DIRECTORATE OF HORTICULTURE

On April 28, 2023, an enriching industrial visit was meticulously organized for M.Com students under the guidance of Mr. Manu Mahajan and Dr. Savita Rana. The destination was the Directorate of Horticulture Navbahar in Shimla, chosen to provide students with a practical, real-world understanding of food product processing, packing, and marketing activities within an industrial setting.

Objectives: The visit was meticulously designed with two overarching objectives:

Real-World Experiences: To immerse students in practical, real-world experiences that extend beyond the confines of a classroom, thereby enhancing their understanding of theoretical concepts.

Problem Identification and Solving: To encourage students to identify and address issues, challenges, or problems in a specific location or situation, fostering critical thinking and problem-solving skills.

The visit commenced with an informative orientation session led by Mr. Kuldeep. During this session, students received valuable insights into the company's history and its primary product offerings, including squashes, jams, pickles, and chutneys.

The highlight of the visit was the tour of the manufacturing unit, where Dr. Nardev Thakur, a seasoned food technologist, demonstrated the intricate production process of squash. Students had the opportunity to witness every stage, from the use of raw materials like fiddlehead for pickles to the inclusion of Rhododendron flowers for squash. They also observed the use of specialized instruments, such as the Defectometer for sugar content measurement, the addition of preservatives and flavours, and the utilization of machinery throughout the manufacturing process. From inception to product completion, students witnessed how raw materials were transformed into finished goods. The importance of batch numbering and product sealing for future traceability was also emphasized.

The visit spanned nearly two enlightening hours, during which students actively engaged with the staff, posing questions that were addressed in meticulous detail. This immersive experience provided students with invaluable practical exposure to the food product processing industry, rendering complex subject matter comprehensible.

Learning Outcome: The industrial visit to the Directorate of Horticulture Navbahar yielded substantial learning outcomes. Students ventured into uncharted territories, exploring the intricacies of food processing while documenting their observations, findings, and experiences for future research reports or documentation. The visit not only bridged the gap between theory and practice but also stimulated critical thinking and problem-solving skills. It afforded students a unique opportunity to witness the inner workings of an industry, enhancing their overall understanding and leaving them better prepared for their future careers.
